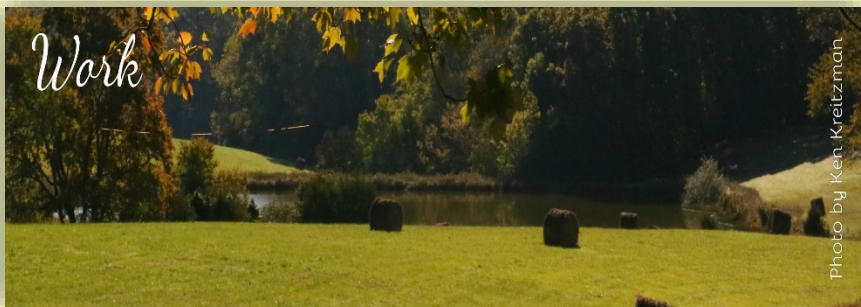

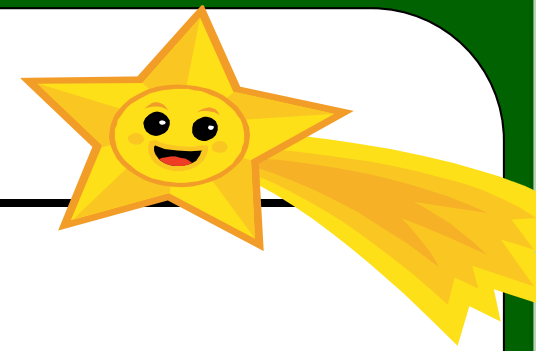

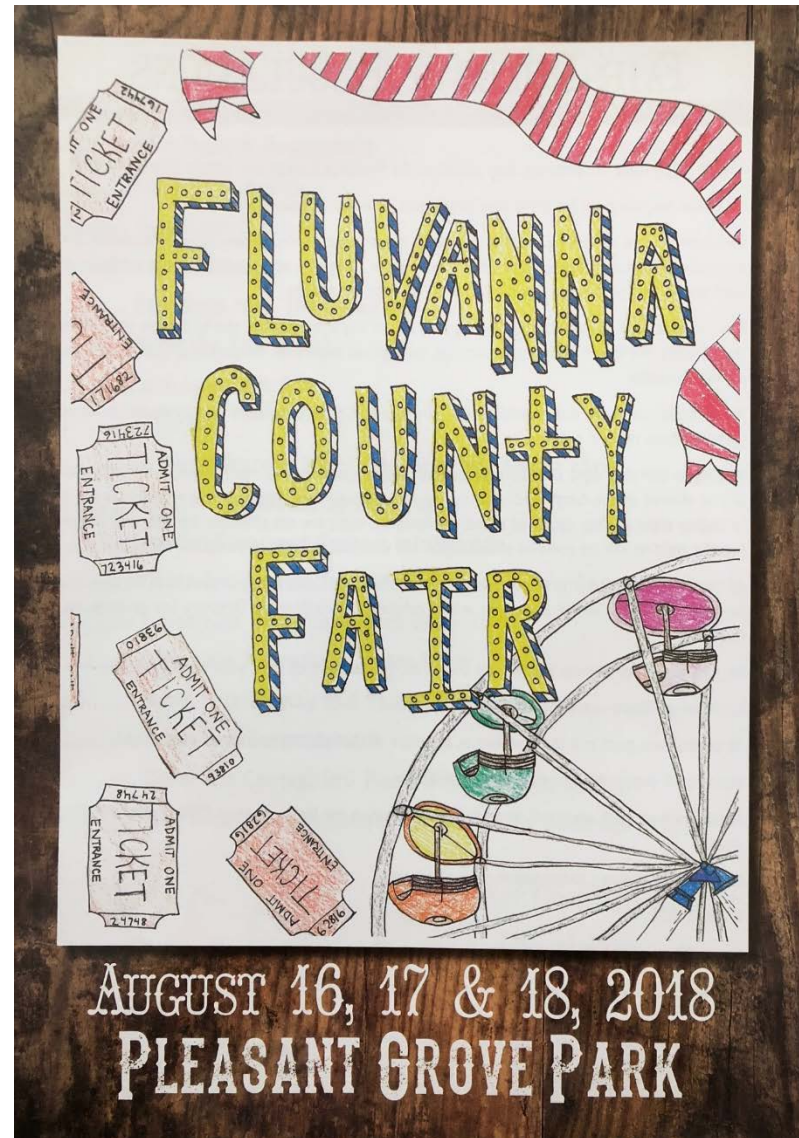


Fluvanna County Fair

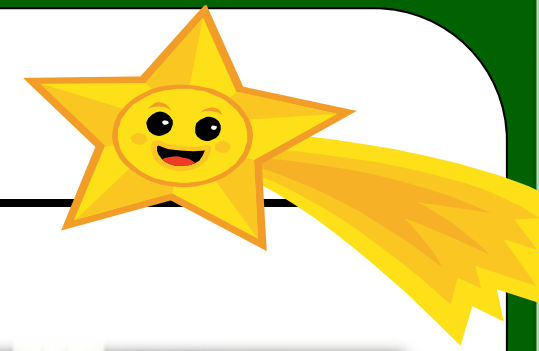

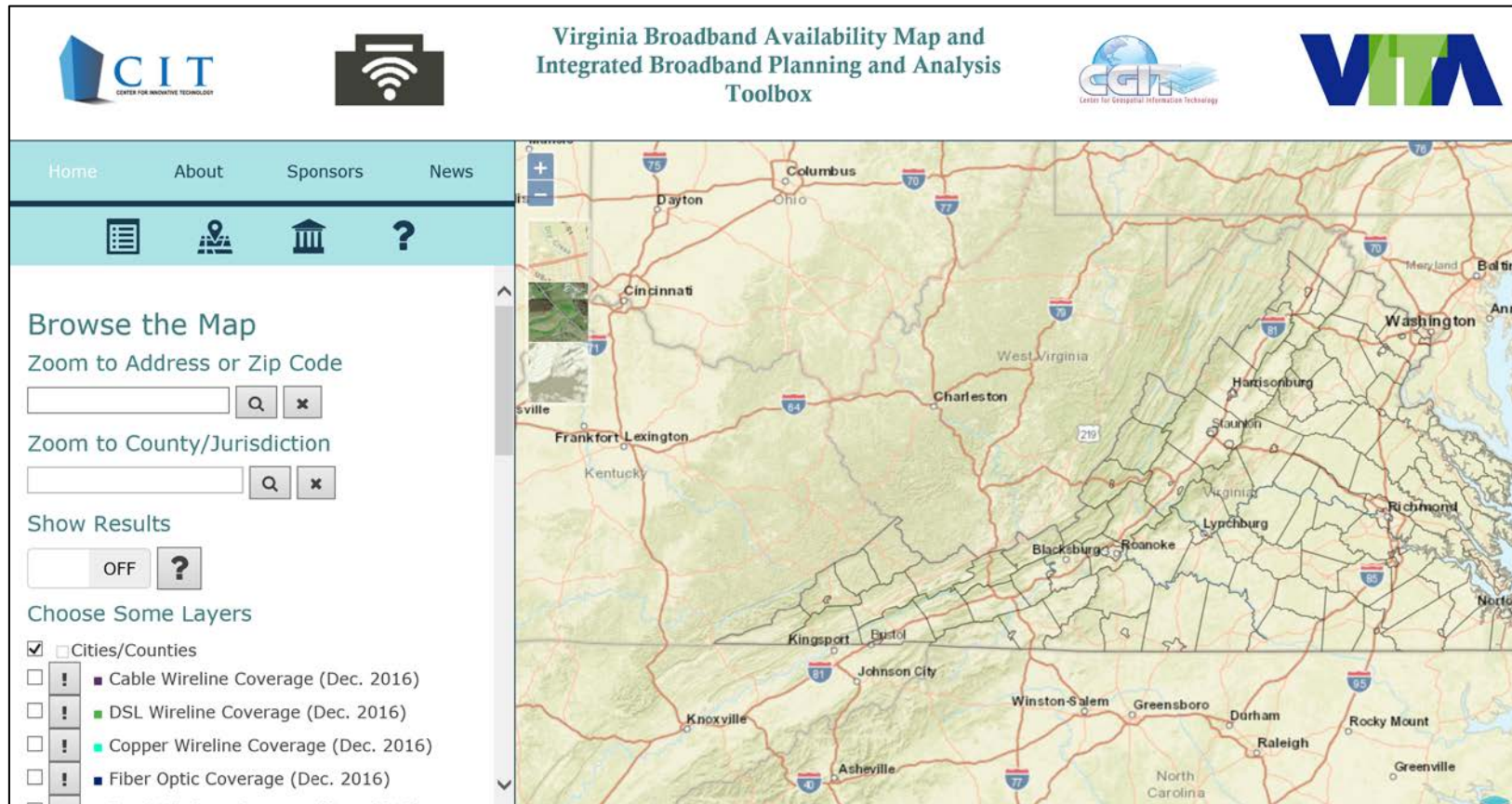

§ 24.2-687. Authorization for distribution of information on referendum elections

EXCERPTS

- Governing body...may provide for the preparation and printing of an explanation for each referendum question to be submitted to the voters of the county, city or town to be distributed at the polling places on the day of the referendum election.
- Governing body may have the explanation published by paid advertisement in a newspaper...one or more times preceding the referendum.
- **Explanation shall contain the ballot question and a statement of not more than 500 words on the proposed question.**
 - Explanation shall be presented in plain English, *shall be limited to a neutral explanation, and shall not present arguments by either proponents or opponents of the proposal.*
 - The attorney for the county...shall prepare the explanation.
- Nothing in this section shall be construed to limit a county...from disseminating other neutral materials or advertisements...; ...shall not advocate the passage or defeat of the referendum question.
