#### 8 - PRESENTATIONS

Board of Equalization 2019 Final Report – Everett Hannah, Board of Equalization Member, gave the Board of Supervisors and summary of actions taken by the Board of Equalization throughout 2019 including,

- 39 total cases heard by BOE
- 38 properties were residential
- 1 agricultural
- 3 properties were reduced
- 1 was increased
- 29 cases did not feel were assessed comparably to other like properties
- 3 felt they exceeded fair market value
- 4 cases were based on incorrect data

#### **Options for Changing County Boundary Line:**


#### § 15.2-3108. Petition and hearing; recordation of order; costs.

Within a reasonable time after a voluntary boundary agreement is adopted by the affected localities, each affected locality shall petition the circuit court for one of the affected localities to approve the boundary agreement. The petition shall set forth the facts pertaining to the desire to relocate or change the boundary line between the localities, and the petition shall include or have attached to it either (i) a plat depicting the change in the boundaries of the localities as agreed; (ii) a metes and bounds description of the new boundary line as agreed upon by the two localities; or (iii) a Geographic Information System (GIS) map depicting the change in the boundaries of the localities as agreed, having been established by Virginia State Plane Coordinates System, South Zone or North Zone, as applicable, meeting National Geodetic Survey standards. If the court finds that the procedures required by § 15.2-3107 have been complied with and that the petition is otherwise in proper order, the court shall enter an appropriate order establishing the new boundary. The order shall include a plat depicting the change in the boundaries of the locality, a metes and bounds description of the new boundary line of the locality, or a GIS map depicting the change in the boundaries of the localities that includes the Virginia State Plane, South Zone or North Zone coordinates, as applicable, and that order shall be entered in the land records of the court and indexed in the names of the localities which were involved. Costs shall be awarded as the court may determine. Whenever such an order is entered, a certified copy of the order shall be sent to the Secretary of the Commonwealth by the clerk of the court.





*Creative EDC Creative Give Back Grant* – Bryan Rothamel, Economic Development Coordinator presented the application process to the Creative Give Back Grant offered by Creative EDC.

- Creative EDC is an economic development consulting company headquartered in Elkin, NC (between Winston-Salem and Boone).
- The company was created in 2012 by Crystal Morphis, CEcD.
- Consulting work includes:
  - Strategic Planning
  - Certified entrepreneurship Community
  - Product development (site characterization)
  - Social media
  - Organizational development
  - Economic impact analysis
  - Back office support
  - Work with clients on site selection
- Creative EDC gives one project a year, up to \$25,000 of value, to a local Economic Development Office.
- The local EDO:
  - Is required to pay for travel expenses.
  - Is able to implement the project.
  - Willingness to allow the project to be publicly available for replication.
- The consulting work needs to be done between April and November.
- The scope of the work clearly needs to be defined.

#### **Previous Winners:**

- 2014: Towns of Indian Trail, Matthews, Mint Hill and Stallings, NC
  - Create an Economic Development Alliance between the towns

- 2015: Cabarrus (NC) Regional Chamber and EDC
  - Attraction of more females in non-traditional jobs to address workforce challenges
- 2016: Wayne County, NC
  - Connecting military spouses and former military to employment
- 2017: Graham, NC
  - Spurring downtown revitalization and entrepreneurship
- 2018: Blacksburg Partnership, VA

  - Transforming a corridor (Gateway Parkway)

#### Criteria for the Grant:

- Judged on:
  - Creativity
  - Innovation
  - Capability for economic transformation
  - Ability to be replicated
  - Demonstrated consulting need
  - A few points for fun (they aren't getting paid, might as well have fun!)
- Creative EDC staff select the finalists. An independent group of judges select the winner.
- We <u>can</u> submit multiple applications.

#### **Potential Financial Commitment:**

- Application (FY20)
- Traveling expenses (~\$5,000) (FY20-21)
- Administrative work for arranging meetings with stakeholders (FY20-21)
- Implementing the project's output. (FY21)

#### Reasons to Submit:

- The FY20 Economic Development budget: \$26,300.
  - \$5,000 is for the ZXR Small Area Plan this year
- A strategic plan that may incorporate these projects would cost \$50,000-\$70,000.
- FY19 we allocated \$10,000 for a strategic plan. That money was unspent.
- This project is distributed widely, giving Fluvanna EDO greater name recognition among economic development professionals.
- We could be used as case studies in the future.

#### <u>Ideas for Submittal</u>:

- Project Fluvanna
  - Creating a workforce pipeline of FCHS graduates for business #FromFluvanna.
  - What are strategic first steps in creating a strong pipeline. This would need FCPS support.
- Fork Union 2030
  - Seeing a true renaissance of the village of Fork Union.
  - The county owns land in the village and there is an industrial building for sale.
- ZXR: Green with Envy
  - Planning and implementing a full greenfield development, centered around water/sewer and fiber.

#### **BUDGET WORK SESSION**

County Administrator's FY21 Budget Proposal and FY22-25 Projected Budgets (The Five-Year Financial Plan) — Eric Dahl, County Administrator

#### FY21 Budget Proposal Highlights:

- Budget totals \$84,519,295
  - Real Estate tax rate of \$0.935 (FY20 \$0.925)
    - Results in a tax increase of 1.08% for the average homeowner.
  - No change to the Personal Property tax rate (Remains at \$4.35 per \$100 of assessed value)
  - No change to the Business and Public Utility Personal Property tax rates (Remains at \$2.90 per \$100 of assessed value)
  - No change to the Machinery & Tools tax rate (Remains at \$1.90)
- Overall increase in total County expenditures by \$1.78 million, a 2.0% increase from the FY20 amended budget
  - Reduction of almost \$7.0 million from the FY21 Operating and Capital budget requests.

#### **Revenues:**

- Projected total revenues will increase by \$1.7 million above the FY20 amended budget amount. The
  most significant contributing factors are:
  - Increase of \$771,400 in tax and local operating revenue.
  - Net increase of \$1,004,210 in Schools revenue (State).
  - Decrease of \$2,602,610 to fund CIP projects.
  - Increase of \$2,822,891 in the Zion Crossroads Water and Sewer Fund (fund balance).

#### **Capital Projects Fund:**

- Difficult decisions were made to recommend only a very few capital projects due existing fund balance level.
- The County has made a practice of using fund balance to fund one-time

unassigned


expenditures.

- Many requested projects of less urgency were delayed until later fiscal years to avoid affecting the tax rates, fund balance or debt service funding requirements.
- Cannot continue to defer essential maintenance, facilities, equipment, and vehicles; before long they will be beyond effective life, potentially compromise safety, or fail at a critical time of use.

• Debt service financing may be required to maintain adequate and safe service levels for the community.

#### **Fund Balance:**

- Fluvanna continues to adhere to a conservative fund balance policy that maintains unassigned restricted fund balance at a minimum of 12% of General Fund revenues and the School Fund revenues, less the County's funding portion from the General Fund.
- As of June 30, 2019:
  - Unassigned restricted fund balance is \$9,125,690.
  - Unassigned unrestricted fund balance is \$7,507,060 (use toward capital projects).
    - Currently \$6,009,239




#### **New Revenue Sources:**

- Staff continues to review and investigate other potential new and existing revenue sources. New sources would include:
  - Business license/registration requirement
  - Vehicle License Fee revisions
  - Building inspections, development, and other service fees revisions
  - Meals Tax; could work on in FY21. If passed by the voters, wouldn't see new revenues until FY22 (~\$300-\$600K annually).


