3 - BUDGET PRESENTATIONS

Treasurer – Deborah Rittenhouse, Treasurer, gave a brief update on DMV holds, delinquent taxes and collections, credit card machine installation, dog tags, and presented the FY26 budget request for the Treasurer's office.

Commissioner of the Revenue – Andrew (Mel) Sheridan, Commissioner of the Revenue, presented the FY26 budget request and highlighted an increase in printing and binding, office supplies and advertising.

Commonwealth's Attorney — Jeff Haislip, Commonwealth's Attorney, gave the Board an overview of the Commonwealth's Attorney Office duties, staffing roles, and weekly court schedule; as well as a summary of Grand Jury and Drug Treatment Court. Mr. Haislip briefed the Board on the FY26 Budget Request, noting that there is only a \$6,000 increase to his budget request for furnishing his office after mold remediation is completed in his office.

Clerk of the Circuit Court – Tristana Pace Treadway, Clerk to the Circuit Court, presented the FY26 Budget for the Clerk of the Circuit Court's office. The FY25 operations budget request includes \$195,000 total operation request, with most of that being reimbursed to the County, for a total of \$41,000 Actual Ask.

Circuit Court Operations Budget – Tristana Pace Treadway, Clerk to the Circuit Court, offered a brief overview of the Circuit Court operations budget request. Jury services went up to \$50 a day per juror, jury commissioners, jury management services have increased.

Sheriff – Eric Hess, Sheriff, introduced Maj. Hurd, who presented an overview of operations and the FY26 budget request; including, budget overview, operating budget, staffing needs, patrol, investigations, court security, salaries and pay increases.

- At 7:00pm, the Board of Supervisors agreed to take a five-minute recess.

Fluvanna SPCA – Ned Ramm, Vice President, briefed the Board on the FY26 FSPCA budget request, and introduced a request for a new building 18 feet wide by 54 feet long on the left side of the current shelter for dog and perhaps cat isolation with an estimated cost is \$315,000.00.

Health Department – Ryan McKay, BRHD Health Director presented the Fluvanna County Health Department FY26 Budget Request with a six percent increase from last year of about \$20,105.

Cooperative Extension – Kim Mayo, Senior Extension Agent gave an overview of the Virginia Cooperative Extension program including staffing and services; and presented the FY26 budget including a 3.7% increase on the salary line only.

Library – Cyndi Hoffman, Director gave an overview of library services and programs, funding, State Library Aid, and revenues. The total FY25 budgeted amount requested is \$ 598,877 (includes estimated \$ 180,333 in State Aid) the Local Funding requested is \$ 418,544. The library is also requesting a new part time programming assistant for \$17,056 (plus \$1,500 new laptop/workstation) for a total of \$18,556.

Registrar – Joyce Pace, Registrar and Scott Newman, Electoral Board Chair, gave a brief overview of the FY26 budget. Discussion included, early voting, yearly June primary elections, updating equipment, and staffing needs.

Social Services – Kim Mabe, Director gave an overview of services including Child Protective Services, Adult Protective Services and Adult Services, and presented the Social Services FY26 Budget Request of \$1,502,723, including three new position requests, a staff pay increase of 3% and a CIP request of a new vehicle for Social Services.

Fire and Rescue Association – John Lye, FRA Chair gave a brief overview of the FY26 requests made. Discussion included, the percentage of fire calls made by each fire company and how the budget request will be divided between the Fire Companies.
