Dear Board of Supervisors:

Enacting a six-seat board of supervisors and school board is simply a wrong decision for several reasons: (1) It will inevitably lead to tied votes which will stall Fluvanna's progress and cost taxpayers money for a decade. (2) It will increase election and board member salary costs. (3) It will cause difficulties with transitioning the five currently-elected supervisors and school board members to a six-seat system. (4) It will have no material effect on representing the residents.

In fact, it seems that the only intent in switching to a six-seat system would be to stall county actions. A split vote on the board of supervisors on the James River Water Authority has already cost Fluvanna hundreds of thousands, if not millions, of dollars. Such a split vote only happens with a rare recusal on a five-member board, but would become a regular occurrence with six members. Any board member who wants to see this county get better should oppose even-number boards.

Except for the likelihood of tied votes, seven-member boards have many of the same problems as six-member: (1) Increased election and board member salary costs. (2) Difficulties transitioning from five-member to seven-member boards. (3) No significant improvement in resident representation.

And, for either six-member or seven-member boards, we would be stuck with those problems for the next 10 years. And neither should be enacted without meaningful input from county residents (other, of course, from just writing to board members, like this), such as town halls, public hearings, and opportunity for testimony.

The alternative is clear: Stick to five-member boards. Since the county population has grown only 6% in the past 10 years, there's little need for additional representatives to adequately meet the needs of the residents. If there's significant growth in the next 10 years, that will be time enough to consider larger boards – fully taking into account the wishes of the residents and the location of any growth.

There's little real difference between the two five-seat scenarios, but 5-version-two probably assures that the most Lake Monticello residents will have at least one supervisor that truly represents them, instead of being a minority of a minority of a non-Lake district.

We sincerely hope the Fluvanna County Board of Supervisors will re-consider its tentative decision to go to six-member boards destined to stall the county for a decade, and stick with

the current five-member system.

--It enhances the likelihood for deadlock on multiple budgetary and operational priorities thereby stalling the County's progress. It makes it too easy for Supervisors to deadlock on issues thereby avoiding action and deferring to the status quo by default.

The 6 district plan skillfully carves up this County's largest population concentration into 2 majority Lake area districts and at least 3 non-majority districts based on today's population count, thereby limiting the citizens comprising over 50% of the County's population to likely representation by just 2 of 6 Supervisors. Pending/planned development also indicates that this will be the County's largest population growth area over the next few years, meaning those citizens will be even more significantly under represented during the latter half of the new plan's 10 year life.

Dear Board of Supervisors,

I am writing about the proposed plans for redistricting to ask that you abandon the Six-Districts Scenario and select the Five-Districts proposal - Scenario #2 instead. There seems not enough of a net population gain to prompt adding a district. Adding a district, or districts, will undeniably involve costs to the taxpayer. Expenses enumerated to date include: pay for BOS and School Board members, administrative costs, and adding one or more polling districts. There is a greater likelihood of the county facing (and the citizens paying for) litigation if you change the current number. There was not enough time to delve into potential unintended costs or consequences so it's unclear what these might be. Common sense dictates that an even number of decision makers provides greater opportunity for gridlock. I understand from Ms. Booker's comments at the November 3 BOS meeting that when Fluvanna had six districts this did happen several times so there is recent, local precedent. If you look at nearby counties, you'll find more represented by five districts (Greene, Madison and Nelson have five; Louisa and Buckingham have seven. Only Albemarle with more than four times our population has six). The two Virginia counties most closely approximating our population (Dinwiddie and King George) have five districts.

I have heard from many friends who likewise oppose the Six-Districts Scenario and their intention was to contact the BOS about the matter; I believe many have done so. At the November 3 meeting the specific number of people who had attended the gatherings to review maps was reported (twelve and three) and it was noted that few emails had been received so far. Mr. Dahl mentioned that during the gatherings some people favored five and some seven districts with no identifiable consensus. I am interested in knowing what feedback you have received on this issue to date and specifically, the numbers of citizens favoring which proposals.

Given the lack of a decision on state redistricting, it seems reasonable to postpone our own decision rather than risk having to repeat the process. Fluvanna would not be the only county taking this position. Regardless of a decision on delaying action, I agree with all the points made by others in support of a five district plan and an opposition to a six district plan. I have read the public comments in the package prepared for the December 1 meeting. I see overwhelming opposition to the six district plan and strong support for a five district plan. If this is the totality of public comment, it cannot be ignored. I evaluate the redistricting proposals in terms of their potential to create political polarization. 2. The 5 and 6 district models both leave a portion of the lake in the Cunningham district. I happen to live in this portion of the lake, near The Acres. The adoption of early voting, and the addition of the registrar's office off of Turkeysag have made life a lot easier, but before this, driving to Antioch baptist to vote was difficult to do with a full time job in Charlottesville, where most of the lake community works. Aside from the difficulties voting, though, I feel there is a large disconnect between the residents of the lake and the rest of this district. Just judging by political signs I see posted in both locations, and based on the way nearly all of the recent elections have gone, there is a large cluster of individuals whose shared interests more closely align with the current Rivanna or Palmyra districts. I am writing to you as well as Mr. Sheridan and Mr. O'Brien concerning the Redistricting Proposals. I wanted to provide my feedback after reviewing the maps on the website.

My husband and I live in the Rivanna district and have for 14+ years. Our address is 594 Jefferson Drive which is in the Tufton section of the Lake a mile from the Monish gate. We would be directly impacted by 3 of the 5 options and would be located in a new district if we change to 6 or 7 districts. While I am not concerned about being in a new district I do have some concerns.

I have read that the Board of Supervisors is considering the 6 district map plan. Before I printed and reviewed the maps this made NO sense to me at all. 6 being an even number could potentially bring votes at any level from Board of Supervisors to School Board to other groups like Planning Commission to a deadlocked tie. In reading I have been more confused by comments made Mr. O'Brien where in one article he wasn't concerned since he "didn't see that as a major concern because county board votes are rarely that closely divided."

(Quoted from Lake Monticello News Facebook page 11/4/2021) The next day on 11/5/2021 another article was posted on that same page where he was quoted "a little flabbergasted" when the Fluvanna county board voted 3-2 to focus on six seats, rather than five, for the county board and school board. And he thinks it could result in 3-3 votes that delay important initiatives and end up costing Fluvanna "a lot of money," So I am very unclear where he stands.

While I understand that the Board of Supervisors may not often have close votes I have watched too many School Board meetings have votes go 3-2 and this could become 3-3 thus causing more problems that that Board already has. Dear Members of the Board of Supervisors:

Members of the Fluvanna Branch NAACP urge members of the Fluvanna County Board of Supervisors to vote to adopt an ordinance that authorizes five voting districts using scenario two.

While we are very concerned that the Board of Supervisors chose to select and propose a plan for establishing a sixth district before the scheduled public hearing, without allowing sufficient time for public comment, and potentially sending the message that there is no room for further consideration, we ask that as elected officials you consider and weigh public comment before making your final determination.

For the best interest of Fluvanna County, our members urge you to maintain five voting districts, using scenario two. This scenario provides the most effective, efficient, and equitable government for Fluvanna County based on the population and demographics of the community.

As has been asserted by Mr. Fred Payne, Fluvanna County Attorney, the five district scenario is easier and less costly to administer. Adding a sixth district will require a special election which will necessitate additional expenses. Likewise, there will be added costs to pay salaries for the additional Supervisor and School Board member, additional administrative and insurance costs, as well as costs associated with adding a polling place. A possible expansion to the planning commission will also result in added costs. For a board that has routinely expressed concern over sound financial stewardship of taxpayer dollars, these costs bear consideration.

Furthermore, as Mr. Payne suggests, maintaining five districts is less likely to face legal challenges. Under Section 2 of the federal Voting Rights Act, the practice of drawing maps that unfairly dilute the voting strength of protected classes is illegal. While there may be no intent to discriminate on the basis of race in determining the best scenario for the community, we ask that Board members consider the practical implications and potential for

discriminatory effects of increasing the number of voting districts and diluting the vote of a protected class of voters.

Thus, we call on the Fluvanna Board of Supervisors to adopt an ordinance that establishes five voting districts using map two.
