I. Chair Garcia convened the assembly of EDA directors at 5:00 PM
Palamountain motioned to approve virtual attendance for Lois Mastro, Bower seconded (6-0)

- III. Unfinished Business Steve Mulroy of VML/VACO Finance presented an overview of the Virginia Investment Pool. Bower motioned to approve a "Resolution Authorizing Participation in the VACO/VML Virginia Investment Pool for the Purpose of Investing Funds Belonging to the Economic Development Authority of Fluvanna County, Virginia in Certain Authorized Investments in Accordance with Sections 2.2-4501 et seq. and 15.2-1300 of the Virginia Code" Palamountain seconded (7-0)
- IV. New Business Richard Hurlbert of Haneberg Hurlburt, PLC presented an overview of the 2010 Region Ten Bond Modification. Potter motioned to approve a "Resolution Regarding the Modification of Tax-Exempt Revenue Bonds by the Economic Development Authority of Fluvanna County, Virginia for Region Ten Community Services Board, Inc." Palamountain seconded (7-0)
- V. County Report Jennifer Schmack reported on one ribbon cutting Local Eats Food Truck. She also visited ten (10) existing businesses, interacted with eighteen (18) partnerships, twelve (12) other activities, three (3) prospect inquiries and one (1) commercial kitchen inquiry.
