II. Approval of Consent Agenda

Motion to approve the Consent Agenda was made by Bower. Seconded by Potter. Unanimously approved 6-0.

- A. Chair Garcia presented the 2024-25 budget. Palamountain moved to approve the budget as amended with the removal of \$250 for the Louisa County Business Summit which has been cancelled. Bower seconded. Budget was passed 6-0.
- B. County Administrator Dahl presented the Final EDA Agreement with Central Virginia Electric Cooperative. CVEC met its commitment on the agreement. The BOS will give the EDA \$500,000 which will be paid to CVEC as per the agreement. Palamountain

moved to accept the Local Taxes Grant payment in the amount of \$500,000 from the Fluvanna County Board of Supervisors, and approve the payment to Central Virginia Services, Inc., for the Agreement dated July 18, 2018 between the EDA, Central Virginia Electric Cooperative (CVEC), and Central Virginia Services, Inc. (CVSI), for the expansion of broadband in Fluvanna County.

- C. Schmack presented the amended Virtual Attendance Policy to comply with Virginia Code. The Bylaws will need to be changed in a subsequent meeting. Bower moved that the Economic Development Authority adopt this Resolution as its amendment to the written policy authorizing remote electronic participation. Hudson seconded. Voice vote was held with all members voting aye. The motion was passed 6-0.
- D. Hudson moved the the Economic Development Authority appoint Dan Whitten as the Freedom of Information Officer. Bower seconded. Motion passed 6-0.

A RESOLUTION REGARDING LOCAL TAXES GRANT TO CENTRAL VIRGINIA SERVICES, INC. FOR BROADBAND DEPLOYMENT

WHEREAS, the Economic Development Authority of Fluvanna County (the "EDA") entered into an agreement on July 18, 2018 with Central Virginia Electric Cooperative ("CVEC") and Central Virginia Services, Inc. ("CVSI") regarding financial incentives provided by the EDA to CVSI to provide broadband internet (the "Project") in Fluvanna County (the "County"); and

WHEREAS, in accordance with the Agreement, the Fluvanna County Board of Supervisors (the "Board") would appropriate funds to the EDA as incentive for CVEC and CVSI to pursue the Project; and

WHEREAS, CVEC and CVSI have completed the Project according to the schedule in the Agreement with allowed extensions for circumstances beyond the control of CVEC and CVSI; and

WHEREAS, CVEC has established at least 10 permanent, full-time jobs in the County in accordance with the terms of the Agreement; and

WHEREAS, CVEC has met the requirements in Section 5 of the Agreement for the local taxes grant with a maximum incentive of Five Hundred Thousand Dollars (\$500,000) ("Local Taxes Grant"); and

WHEREAS, CVEC has paid all local taxes to the County that are due; and

WHEREAS, the Board approved a motion at its meeting on April 3, 2024 to approve the Local Taxes Grant payment to the EDA; and

WHEREAS, since CVEC and CVSI have met the terms of the Agreement, the EDA shall accept the Local Taxes Grant payment from the Board and approve the Local Taxes Grant payment to CVSI.

NOW, THEREFORE, BE IT RESOLVED, the EDA accepts the Local Taxes Grant payment from the Board in the amount of Five Hundred Thousand Dollars (\$500,000) and approves the Local Taxes Grant payment in the amount of Five Hundred Thousand Dollars (\$500,000) to CVSI.
