## CALL TO ORDER

Chairman Watson called the meeting of the James River Water Authority (JRWA) Board of Directors to order at 9:00 a.m. and led the Board in the Pledge of Allegiance.

### APPROVAL OF MINUTES OF PRECEDING MEETING

On the motion of Mr. Anderson, seconded by Mr. Dahl, which carried by a vote of 4-0, the Board approved the meeting minutes of January 10, 2024.

### FINANCIAL REPORT

Mr. Dahl reviewed the bills put forward for consideration and briefed the Board on the current bank balance. Mr. Dahl noted that the amount of the bills are \$1,243,595.90 and the bank balance is at \$518,253.22, and they will need to request funds from outstanding debt proceeds to cover the bills. On the motion of Mr. Anderson, seconded by Mrs. Eager, the bills were approved by a vote of 4-0.

## PUBLIC INFORMATION AND DISCUSSION

### **Discussion – Project Status Update**

Joe Modica provided the following updates:

- MOA was submitted on January 26, 2024, and the revised Phase III plan was submitted February 13, 2024.
- Property acquisitions are ongoing with 9 out of 17 properties deeded.
- VDH permits are expected by March 2024.
- Non-permitted pipeline construction is anticipated to begin April 2024.

Bryan Reickmann provided the following update:

• Trees along the pipeline route will begin to be felled February 26, 2024 in order to meet the April 1, 2024 deadline. Once the plans are approved, with trees are on the ground, non-pipeline construction can begin right away.

Eric Dahl provided the following update:

• In order to obtain VRA funding and what will be an anticipated loan condition, we will need to have the Army Corp. of Engineers permit in hand as off April 15, 2024.

Justin Curtis provided the following update:

- It is unlikely to receive a conditional permit
- Prepared documents are scheduled to go out Friday, February 16, 2024. The review period will end mid-March, and potential decision made by mid-April to early May.
