Absent: D. D. Watson (Chairman)

CALL TO ORDER

Chairman Watson called the meeting of the James River Water Authority (JRWA) Board of Directors to order at 9:00 a.m. and led the Board in the Pledge of Allegiance.

ADOPTION OF AGENDA

Mr. Goodwin asked that consideration of an engagement for phase 2 cultural resource efforts be added to the agenda. On the motion of Mr. Dahl, seconded by Mr. Anderson, which carried by a vote of 4-0, the agenda was adopted as amended.

ITEMS FROM THE PUBLIC

(none)

APPROVAL OF MINUTES OF PRECEDING MEETING

On the motion of Mr. Anderson, seconded by Mr. Dahl, which carried by a vote of 4-0, the Board approved the minutes of the August 10, 2022 meeting.

FINANCIAL REPORT

Mr. Dahl briefed the Board on bills in the packet for consideration, noting that the Authority had a current balance of roughly \$482,000. On the motion of Mr. Goodwin, seconded by Anderson, the payments were approved by a vote of 5-0.

PUBLIC INFORMATION AND DISCUSSION

Discussion – Corps of Engineers (COE) Permit

Mr. Curtis reported that the COE has begun consultation on the permit. He reminded the Authority that the permit from the Department of Environmental Quality was the longest lead time in the permitting process at the current juncture. As of August 25th, the Joint Permit Application is complete and consideration is underway.

Discussion – Comprehensive Agreement Addendum

Greg Krystyniak of Faulconer Construction stated that the proposed addendum would update the existing Comprehensive Agreement. The cost estimates are finalized although there are some edits remaining in the work description, and the cost includes a performance bond. The effort would include the full survey requirements, identification of any underground utilities, preliminary design, and the easements necessary for right of way acquisition. Coordination with the railroad, plats for easement acquisition, and electrical design would also be included, and borings would be conducted at several sites.

Mr. Watson asked about the \$20K increase, and Mr. Krystyniak responded that it was largely due an allowance for additional parcels. Mr. Purcell asked about the railroad crossing, and Mr. Krystyniak responded that it should not be an issue based on their prior experience. Mr. Anderson asked about the bond. Mr. Krystyniak stated that it was a performance bond, and general discussion about a bond ensued. Mr. Goodwin asked about the 15% design level, and Mr. Saunders responded that it would likely be an even higher level of design than that.

Mr. Dahl noted that the total design cost would be much higher if \$338K was for only 15%. Mr. Goodwin also asked about the use of Lump Sum versus Guaranteed Maximum Price, and Mr. Krystyniak said that the effort would be a Guaranteed Maximum Price. Mr. Dahl noted that project acquisition service costs sound high, and Mr. Krystyniak responded that they were the best prices he could obtain. A discussion about costs under the addendum versus costs in the existing and ongoing project budget lines ensued, as well as scheduling of the efforts. The Board stressed the importance of moving away from the existing project coordination billing structure to billings under cost buckets in the addendum, going forward. On the motion of Mr. Purcell, seconded by Mr. Anderson, which passed by a vote of 5-0, the JRWA authorized the Chair to execute the addendum after consultation with counsel and with Mr. Dahl and Mr. Goodwin regarding the scope and fees.

ACTION ITEMS

Consulting Engineer Engagement

Mr. Dahl summarized the need for oversight on the project by a subject matter expert now that the effort was moving forward, and reviewed the offering by MBP Engineering. On the motion of Mr. Goodwin, seconded by Mr. Dahl, the Board approved the execution of the agreement by a vote of 5-0.

Phase 2 Cultural Resources Efforts

On the motion of Mr. Goodwin, seconded by Mr. Purcell, which passed by a vote of 5-0, the Board approved the phase 2 cultural resources engagement with Goodwin and Associates and authorized the Chairman to enter into a contract for an amount not to exceed \$459,117.17 in a form approved by JRWA legal counsel. Mr. Goodwin noted that he had no connection to the company.
