Your community group, school, or business can help keep Fluvanna beautiful and litter free!

Fluvanna's Adopt-A-Spot program gives people of all ages the opportunity to learn about and participate in the preservation of our parks, streams and other natural resources. By adopting a spot, partners will not only make a difference in the cleanliness of our parks and open spaces, but also learn to practice conservation in our backyard. Here's how you can help!

1. Select an approved spot and commit to clean it at least 3 times a year for two years, rally your team and get them excited about making a difference. They will see immediate results!
2. Call 589-2016 to advise when you want to pick up supplies (gloves, safety vests, trash bags, roster sheet(s), etc.) and how many people will be participating. Please give at least 1 week advance notice. Don't forget to state your group's name!
3. Review safety guidelines with your group before starting; These can be found on the back of the reporting form.
4. Pick up your supplies at the one of our Parks and Recreation Operation Centers.

5. After your clean up, please complete the Reporting Form (provided with your supplies and can also be filled out on line at [Adopt-A-Spot program report](#)) and return supplies. **Thank you for helping keep Fluvanna County clean and beautiful!!!**

ADOPT-A-SPOT Agreement

Fluvanna County's Adopt-A-Spot program is an effort to encourage residents, organizations, and local business participation in litter and invasive weed cleanup of designated areas in our community at regular intervals. Individuals, organizations or businesses may agree to keep a designated area, other than a highway, cleared of litter, brush, and weeds for no less than a two year period.

In exchange, program participants are given materials to help them with the cleanup and a sign bearing their name to be posted in the area. At the end of the two year period, the program participants will receive a special certificate of appreciation and may also renew their agreement.

ADOPTABLE LOCATIONS include parks, vacant lots, parking lots, walkways, specific trails, boat ramps, public grounds or other littered areas set by the Department of Parks and Recreation.

Parties interested in Highway cleanups will need to contact to the Virginia Department of Transportation's Adopt-a-Highway division at 1-800-FOR-ROAD (1-800-367-7623) or e-mail adoptahighway@VirginiaDOT.org. Those parties interested in locations other than highway cleanup are encouraged to participate in Fluvanna County's "Adopt-A-Spot" program.

Terms and conditions

1. All members must sign the release of liability, which is necessary to participate in cleanups. The release can be signed at the cleanup the day of the event if the participant is 18 or older. Minors under the age of 18 must have the release signed by a parent or legal guardian. The group agrees that the release is effective during the time of this Agreement and to be responsible to obtain and maintain signed releases for members that join any time during the term of Agreement.
2. After each cleanup, adopting groups must file an activity report form detailing the number of people involved, number of bags left, how many pounds of recyclable materials were separated out/type of material if known, and hours spent. Printed forms will be provided by Fluvanna County Parks and Recreation, or you may submit report online at [Adopt-A-Spot program report](#). Completed forms must be delivered/sent to Fluvanna Parks and Recreation, Adopt-A-Spot Program, P.O. Box 70, Palmyra, VA 22963 or dropped off with supplies.
3. All participants shall review all safety precautions prior to each cleanup and agree in writing to assume the risks involved in the work by signing the release form.
4. The group agrees to notify the Department of Parks and Recreation at least one week prior to the planned cleanup time.
5. The group agrees to Adopt-A-Spot for a minimum of two years, with a renewal option decided upon by both parties.

6. Participants under the age of 18 must be accompanied by a person over the age of 18.
7. The group shall cleanup a minimum of three times per year during the two-year adoption period.
8. All persons engaged in the Adopt-A-Spot program must use and/or wear appropriate safety equipment to complete the job.
9. Adopt-A-Spot cleanups must be done by two or more people during the daytime. No individuals from the group may undertake Adopt-A-Spot work alone.
10. The group shall obtain Department of Parks and Recreation furnished materials during regular working hours (trash bags, gloves and release forms). Unused trash bags, gloves, and release forms shall be returned back to the Department of Parks and Recreation during regular working hours within one week following the cleanup.
11. The group will place filled trash bags at locations designated by the Department of Parks and Recreation for easy pickup by County staff. Trash will be removed and disposed of by Fluvanna County on the next working day.
12. If group finds litter that is too large to remove safely, inform the Department of Parks and Recreation of its location for removal, which prevents personal injuries and maintains county property.
13. Use of controlled or illegal substances (including alcoholic beverages) is prohibited.
14. The group shall not trespass or interfere with the rights of private landowners.
15. The group shall notify the Department of Parks and Recreation immediately of the occurrence of any injury to any person or accident which occurs during litter pickup.

Fluvanna County Parks and Recreation agrees to

1. Provide recognition of participation in the Adopt-A-Spot program in information about the Adopt-A-Spot program on Fluvanna County's Parks and Recreation website and in printed materials, when applicable.
2. Provide materials to participating Adopt-A-Spot groups including, but not limited to: trash bags, latex gloves, activity report forms and release of liability waivers.
3. Provide safety information to participating Adopt-A-Spot groups.
4. Remove the collected trash on the following working day after an Adopt-A-Spot cleanup event.
5. Assist the Adopt-A-Spot group in planning and at the initial information and safety meeting, when given proper notice of the event.
6. Provide a sign recognizing the Adopt-A-Spot groups commitment on the adopted site within 1 month of the groups anticipated first clean up date.

SAFETY GUIDELINES

Please review with all participants before cleanup.

1. Dress appropriately; loose clothing (long sleeved and long pants) are best.
2. Make participants aware that they are working in a potentially dangerous environment and caution them to act accordingly.
3. Wear closed toe shoes.
4. Keep work group to a manageable size.
5. Closely supervise any youth groups. Volunteers age 12 and under should be discouraged from working in or near roads and streets.
6. Always wear your safety green vests the department provides.
7. Wear rubber, work, or gardeners' gloves.
8. Children under 12 years of age must be supervised by someone at least 18 years of age (no infants please).
9. No litter is to be picked up in the street or on roads. Participants must stay clear of traffic at all times.
10. Do not pick up trash in tunnels, bridges, or overpasses.
11. Do not remove or pick up hazardous or any other chemical materials – call in item/location to 589-2016.
12. Be aware of poison ivy, poison oak, etc.
13. Be aware of insects, ticks, chiggers, snakes, etc.
14. Be sure to take breaks whenever needed.
15. Do not schedule outings during inclement weather, hours of darkness or hours of peak traffic.
16. Do not allow participants to consume, possess or distribute alcoholic beverages while participating.
17. Wear sunscreen and insect repellent.
18. Drink plenty of fluids in extreme temperatures.
