CORRECTED WRIT OF SPECIAL ELECTION

THIS CASE came this day on Motion of the Petitioner, Town of Scottsville, Virginia, pursuant to Va Code §8.01 – 428 (B) to correct clerical mistakes in the Order of this Court dated November 27, 2024.

IT APPEARING that the Writ of Special Election entered by the Court on November 27, 2024, has clerical mistakes in that the date of the ordered Special Election is listed as November 5, 2025, instead of the correct date of November 4, 2025, and that the date of Meredith Hynes' resignation is stated as October 14, 2024, instead of October 22, 2024; that a writ of special election is not required to be verified by the Va. Code; and it further appearing to the Court that Va. Code Section 8.01 - 428 (B) authorizes the Court to correct such typographical errors upon motion of the sole party in this case, the Town of Scottsville, Virginia, who has so moved, and finding it proper so to do,

IT IS ACCORDINGLY ORDERED as follows:

IT APPEARING to the Court by a Petition for Writ of Special Election filed by the Town Council of the Town of Scottsville, Virginia (the "Council"), by counsel, that a vacancy exists on the Council as a result of the resignation of one of its members, Meredith Hynes, on October 22, 2024;

NOW, THEREFORE, after the Court's review of the Petition for Writ of Special Election, it is hereby ORDERED as follows:


1. Pursuant to Va. Code § 24.2-226, this Writ of Special Election IS HEREBY ISSUED AND ENTERED; and the Electoral Board of the County of Fluvanna (the "Electoral Board") shall take steps and prepare such means as may be necessary to hold the special election on the date of the regularly scheduled November 4, 2025, general election for the Town of Scottsville to fill the vacancy on the Town Council of the Town of Scottsville, in the manner and at the places as would be executed for the general election to be conducted on such date; and

2. The Electoral Board and General Registrar of the County of Fluvanna (the "General Registrar") shall observe the directives set forth in Virginia Code § 24.2-681, *et seq.* when conducting the special election; and

3. The Secretary of the Electoral Board of the County of Fluvanna shall cause notice of the special election to be published once in a newspaper of general circulation in this jurisdiction at least ten (10) days before the special election and to do all things as prescribed by law to conduct such an election of a person to serve the portion of the remaining term of the office now vacant; and


4. The Clerk of this Court shall transmit a certified copy of this Writ of Special Election to the Honorable John O'Bannon, Chair of the Virginia State Board of Elections, Daniel Graff, the Secretary of the Electoral Board of the County of Fluvanna, Joyce Pace, General Registrar of the County of Fluvanna, the Honorable Ron Smith, Mayor of the Town Council of the Town of Scottsville, Melodye Courter, Clerk of Town Council; the Clerk of the Circuit Court; and counsel for the Petitioner. The Clerk is also directed to post an attested copy of this writ in at least one public place.
